## 2020 ATSNZ Expo

We are looking forward to the next ATSNZ Independent Living Expo. In our 'save the date' communication we asked you to save 30th April/1st May, but in the process of organising the expo and listening to feedback from the surveys, we concluded that it is better to shift the expo to early September.

This year's venue, although pleasant, was a bit cramped and not as wheelchair friendly as we'd like it to be. The venue we've decided on is the Vodafone Events Centre in Manukau, easy enough to get to for Aucklanders and reasonably convenient for others, in terms of proximity to the airport and SH1. We're planning for a 2-day show, packing in the day before. The start time will be 10.00 AM and finish times will be 4:00 PM and 3:00 PM.

### aSAP Online Portal

Accessable launched their aSAP portal on the 16th August. As with any new system, it is taking time for users to become familiar with this new system and this has taken a toll on many of you. Initially, suppliers had access to the system, but since 9th September this has been rescinded, until a date yet unknown. We asked for your feedback after two weeks of experiencing aSAP and collated this to share with Accessable. It hasn't been easy to get a meeting to discuss the feedback and work with them towards a lessening of the pain suffered. We have also



shared your views with ACC and the Ministry of Health and have been assured that they are aware of the issues and are monitoring the situation. aSAP is not what it was promised to be and some of the issues are ongoing. It is important to keep updating us on your experiences and the impact that the launch of the new system is having on you, the assessors and their clients.

The Deputy Director General Disability is travelling around the country consulting about Disability Support Services. We attended the Auckland session to hear more about the strategy being developed and what service providers are contributing to the conversation. This is primarily an opportunity to network with people in the sector who have an influence on strategic decision making.


#### **Committee Member Roles**
