ATSNZ AGM - 31 August 2023



This year our AGM will be on 31 August. We will host those that can come to the AGM at the Jetpark in Mangere, not far from the airport. We will also have AV onsite so that those who can't make the trek to Auckland are able to connect in via Teams and be present.

After the formal part of the meeting, we have a guest speaker lined up for you, Sophia Malthus, who is a third year LLB student at Auckland University of Technology, with interests in employment and health law.

In 2016 Sophia sustained a high-level spinal cord injury and has been active in the disability community since, particularly concerning advocacy and representation in the media. This ranges from taking disability residency and rehabilitation issues to Parliament, to runway modelling for New Zealand Fashion Week 2019 and playing a lead role in a TVNZ drama.

Through her unique life experience, she has developed strong resiliency, problem solving, and communication skills. Sophia has developed a series called This Is Wheel Life. This series explores what life in their 20's looks like for Sophia who is quadriplegic, and Indy who is Sophia's carer and cousin. It is made with the support of NZ On Air.

THERAPEUTIC PRODUCTS BILL



The Health Select Committee have published their report https://selectcommittees.parliament.nz/v/s electCommitteeReport/79a6a4a8-869e-452d-62b1-08db6bb870b9 after 16,756 submissions were reviewed.

Despite numerous submissions there were few changes to the legislation affecting medical devices. The relatively minor changes suggest that the bill will be passed before the Election.

ENABLE UPDATE



Enable has had some extreme issues with their new financial system and as a result suppliers were not getting some or most of their invoices paid. We've been monitoring the situation and having conversations with Enable on your behalf.

We sent you all the details of our last meeting on 25 May, where we garnered some confidence that the problems would be resolved, and payments would start returning to normal. Early feedback on the June payments suggests that progress is being made. However, there is still a substantial backlog for some and we need to keep the pressure on.

WHAIKAHA UPDATE



Since our last newsletter we have had two meetings with Whaikaha, Enable, Accessable and OTs to discuss the best way forward for equipment trials.

At the most recent workshop, all parties had the opportunity to share what they considered to be the role and responsibilities of the various parties. Most participants concentrated on their own roles and responsibilities and it was a good exercise to bring into view where the complexities sit.

Work continues with all parties, and we expect to see a graphic overview of the process at the next meeting. Timeframes were brought into the discussion, and we emphasised the need for a process that minimises the time that equipment is out on trial. Good support for this approach was seen amongst some of the OTs participating in the workshop.
