

# **Executive Officer Update**

# 12 August 2024

# AGM:

- Date: 19 September, 11 AM -1 PM.
- Location: Jetpark Auckland.
- Nominations: 4 so far (3 existing and 1 new), closes 16 August.
- The agenda and list of nominated members will go out end of August.
- Speaker: team from Accessable.
- Accounts are ready, small loss for 23/24 financial year.

## Enable:

- ATSNZ members meeting at Enable 31 July was a success, with 18 members attending.
- The presentation was made available to ATSNZ members under strict confidentiality agreement. Content not to be shared outside of the group.
- I've set up monthly meetings with Scott Ambridge to work with Enable on sector improvements.
  - End-to-end review of the trials process likely starter. Setting up a small working group Katie, Chris, Andrew and Levi.

# Accessable:

- Meeting to view and discuss the 23/24 June report to Whaikaha.
- Standards Graham and Tertius asked about our involvement in standards review and I put them in touch with Matt Butterworth (Sunrise Medical - who has left the ME-067) and Kim Chapman (Medifab) and Lauren Roberts (Cubro) for feedback (both still on the joint committee ME-067). Matt responded and his feedback was passed on to Nicky Bank at Whaikaha to relay to Standards New Zealand. Standards NZ took this on board and are keeping the standards in place. Standards Australia are withdrawing the standards for wheelchairs and bath boards as the ME-067 advise they were outdated but haven't produced updated standards to date. As such they will be disjointed.
- AGM: agreed to speak on 19 September, 30 mins before or after the AGM business.

# <u>Whaikaha:</u>

- I set up 6 weekly meetings with Nicky for continuity of contact and discussions, next meeting 15 August.
- Nicky Bank and Sarah Payne can present at our seminar, with ATSNZ covering travel expenses as they currently have a travel ban.
- Monthly reports from Enable and Accessable to Whaikaha made available to ATSNZ.

- Nicky Bank rang me with regard to the standards for manual wheelchairs and bath boards that were up for review. I updated her on the assistance I'd provided to Accessable and forwarded Matt's response to keep her in the loop.
- Todd Stevenson and Laura Trask are interested in hearing about AT sector specific processes in procurement. Follow up meeting to be organised.
- Another OIA for the 22/23 monthly reports, due 27 August.

## ACC:

- The Enable reports to ACC for the 12 months 23/24 financial year have been requested through an OIA.
- Anushka Nand (portfolio manager) is preparing a presentation for the expo seminar sessions and will attend with her colleague Janice Gray.

## <u>Pharmac</u>

- Chris, Andrew and I have been having discussions with Todd Stevenson, MP for Invercargill (ACT) and advisor on the Pharmac reform.
- Based on 8/8/2024 meeting with members contacted to Pharmac, we'll create a document that a) outlines the key challenges faced by ATSNZ members in dealing with procurement across government agencies, particularly PHARMAC, HSC, and hospital supply chains. This document will also b) include our vision for an ideal state for medical technology purchases in the sector. Once drafted, we will share this document and collaborate with MTANZ for consistency, and then progress with the next steps.

## Minister for Disability Issues:

• The minister's team passed on our concerns for the disabled community as a result of the budget caps and prioritization procedure to the review panel.

#### MTANZ:

- Attended the MTANZ conference and spoke with Catherine Epps and Andrew Davies from Pharmac (and others) during the breaks.
- The MTANZ hosted supplier's forum is a good way to keep up to date with what is happening at Health NZ and Pharmac. A survey is currently underway for suppliers to provide their views on direction and expectations. The link to this survey has been supplied to our members.

#### <u>NZDSN</u>

- Contacted Peter Reynolds to promote our expo not very helpful.
  - Membership starts in September if we wish to rejoin.
- Contacted Peter Reynolds to find out what involvement they've had in the Whaikaha review negligible.

- Contacted Mike Potter to find out what involvement they've had in the Whaikaha review none.
